## **Rent-to-Buy Agreement**

## **1. COMMENCEMENT AND DURATION**

- a. This lease shall commence on \_\_\_\_\_**202**\_\_\_\_\_ and shall endure until \_\_\_\_\_**202**\_\_\_\_\_.
- b. \*Notwithstanding 1.a, this lease shall not terminate after the initial period but shall continue to endure thereafter on a month-to-month basis, subject to the right of either party to terminate the lease on one calendar month's notice in writing to the other party.

## **2. RENTAL/LEASE AMOUNTS**

- a. Standard Security Deposit is based on the value of the vehicle which is:
  - i. R5,850 per Zbee RS
  - ii. R6,750 per Zbee Cargo
  - iii. R2,875 per Velaphi City
  - iv. R3,250 per Velaphi Roamer
- b. The monthly fee payable by the LESSEE to the LESSOR shall be an amount of R\_\_\_\_\_ per month.
- c. Green Scooter reserves the right to a price/lease/rental increase that is in line with inflation rates as per economic trajectory and activity. The increase will take into account global economic factors that could impact our supply chain models and distribution of products.
  - i. Green Scooter agrees to provide the LESSEE with standard aftersales and support for the duration of the lease (24 months). Thereafter, it is the responsibility of the lessor to ensure that they have purchased any further maintenance plans or services from Green Scooter to continue receiving support from Green Scooter.
  - ii. Green Scooter agrees that all ownership transfers (RC1) will be handed to the new product owner under the details requested by Green Scooter.
- d. The Lessee shall be informed in writing of a price/lease/rental increase 30 days prior to the actual increase.
- e. **Advertising [Mandatory as per the new e-hailing regulations]**
  - i. Advertising Rates are R2 000 payable monthly.
  - ii. Full Digital Wrap with UV Lamination Cast R13 095 - Once off payment.
  - iii. For Half-Digital or a smaller set of decals, the Lessor would be required to provide their artwork and provide a brief with the dimensions for a quotation to be provided.

## **3. LESSEE'S OBLIGATIONS**

- a. The Primary Driver/Lessee will adhere to all requests by Green Scooter in respect of the servicing of the vehicle and will ensure that all services required are met within the deadlines of Green Scooter and/or the

manufacturer. Should the Primary Driver/Renter fail to have the vehicle services as set out Green Scooter will be entitled to recover any loss or damages suffered from the Primary Driver/Lessee.

- b. The driver holds a valid unendorsed driver's license A or A1 for the vehicle.
- c. The Lessee and the driver will at all times display an absolute duty of care towards the Scooter in respect of the vehicle, and the Lessee will ensure that the vehicle will only be used on suitable roads and conditions under the type of vehicle hereby rented.
- d. The Lessee shall ensure to insure the vehicle with an obligatory insurance cover of R422.55 per month (to be included in the LEASE/RENTAL amount).
- e. It will be mandatory for the LESSEE to ensure that they have their own separate comprehensive insurance in the event that other services, besides the transporting of goods, are rendered using either of our products.

#### **4. LIABILITY WAIVER**

- a. You waive the right to have a claim from/to Green Scooter in the event of third-party liability in the event of an accident/collision or injuries from the use or leasing of our products.
- b. In the event of a breach of this agreement, you waive all rights and or any claims made against Green Scooter.
- c. Where the vehicle/unit is neglected from being checked periodically for mechanical, electrical and other possible faults - no claim can be made against Green Scooter. Green Scooter shall and should be informed of any faults at all times.
- d. Waive all claims against Green Scooter in the event of the following:
  - i. Water damages by negligence
  - ii. Driver negligence
  - iii. Damages or loss due to potholes, travelling on gravel roads and sandy roads
- e. Where the company or the driver are in breach of this agreement.
- f. Where significant damage is caused to all glass, mirrors, lamps, tyres, rims, hubcaps, hub motors, windscreens or the undercarriage if no collision of the vehicle has occurred.
