



Welcome to Green Scooter (Pty) Ltd. Standard Leasing Terms and Conditions

Which limits your rights - please read carefully.

Updated: Tuesday, 11 October 2022

1. DEFINITIONS

In this AGREEMENT, unless the context indicates otherwise, the following expressions will bear the following meanings:

- 1.1. "Scooter", "OUR", "US" and "WE" means GREEN SCOOTER (PTY) LTD, trading as SCOOTER;
- 1.2. "the RENTER", "YOU" or "YOUR" means the renter of the VEHICLE, as indicated in the AGREEMENT and who must be 23 years old or older and who must have held a valid unendorsed driver's license for a minimum period of 2 years before the AGREEMENT;
- 1.3. "The DRIVER" means YOU and/or the driver and/or the ADDITIONAL DRIVER as indicated in the AGREEMENT and who must be 23 years old or older and who must have held a valid unendorsed driver's license for a minimum period of 1 year before the AGREEMENT;
1.3.1. The Clean Motion Zbee RS or Zbee CG requires a Motorcycle A or A1 license.
- 1.4. "DAY" means a period of 24 hours (or any part thereof) calculated from the time the vehicle is received by YOU;
- 1.5. "the VEHICLE" means the VEHICLE/s identified in this AGREEMENT or any other replacement vehicle provided to YOU by US (including the VEHICLE documents, keys, tyres, tools and accessories supplied with the VEHICLE);
- 1.6. "the RENTAL PERIOD" means the period between the date when the vehicle is taken out by YOU and the termination date and time as specified on the AGREEMENT or, if such period is extended, the time and date entered on OUR records as being the date and time when the VEHICLE is returned to US;
- 1.7. "The OFFICIAL RATES" means OUR rates charged from time to time and/or in terms of the official rates published and amended from time to time, applicable to the VEHICLE rented in terms of this AGREEMENT, and which are available at any of OUR offices;
- 1.8. "AGREEMENT" means the rental agreement and these terms and conditions.
- 1.9. References to the singular will include the plural, the male gender will include the female gender, and references to persons will include natural and juristic persons.
- 1.10. "MINI-LEASE" means that there is a dedicated rental vehicle provided to the client between 3 - 48 months.

2. MiniLease

2.1. The minimum qualifying rental length is 3 months. A R5 000 early termination charge will apply in the event the rental is terminated for any reason (other than by Scooter as provided for in this agreement) before the expiry of 3 months.

2.1.1. Standard Security Deposit is based on the value of the vehicle which is R5 354 per Zbee. **Inclusive of VAT.**

2.1.2. **The Lease Fee for the Zbee is R5 354 per month for the duration of the agreement. Exclusive of VAT.**

2.1.2.1. The lessor agrees to lease ___ Zbee RS/CG for a duration of ___ months.

2.2. A maximum of 2 additional drivers will be allowed per vehicle. The additional drivers will be limited to the individuals noted on the Mini Lease Order Form.

2.3. The Primary Driver/Renter will at all times remain liable for the vehicle and will ensure that any additional driver adheres to this agreement of rental as it appears on the agreement.

2.4. If the vehicle is delivered to or collected by any other person than the Primary Driver/Renter (provided that the person taking possession of the vehicle must be one of the nominated additional drivers), Scooter will deem the person so taking delivery of the vehicle as being a duly authorised and appointed agent acting on behalf of the Primary Driver/Renter.

2.4.1. Receiving Party of the Zbee will be operating on behalf of _____, signed at _____ on the expected delivery date _____.

2.5. The Primary Driver/Renter will adhere to all requests by Scooter in respect of the servicing of the vehicle and will ensure that all services required are met within the deadlines of Scooter and/or the manufacturer. Should the Primary Driver/Renter fail to have the vehicle services as set out Scooter will be entitled to recover any loss or damages suffered from the Primary Driver/Renter.

2.5.1. Please note that the servicing of the Zbee RS/CG is done every 8 500km.

2.5.2. Each Zbee leased by the client is limited to 3 000km per month, should the user exceed the mileage then the client will be obligated to pay a rate of R1.50 per kilometre thereafter.

2.5.2.1. The Service intervals are as follows:

2.5.2.1.1. 8 500km

2.5.2.1.2. 17 000km

2.5.2.1.3. 25 500km

2.5.2.1.4. 34 000km

2.5.2.1.5. 42 500km

2.5.2.1.6. 51 000km

2.5.2.1.7. 59 500km

2.5.2.1.8. 68 000km

2.5.2.1.9.76 500km

2.5.2.1.10.85 000km

2.5.2.1.11.93 500km

2.5.2.1.12.102 000km

2.5.2.2. Please note that with regards to the service intervals of the Zbee, this is merely for check-ups on the vehicle to ensure that the hardware is intact and functioning as it should as your personal or business-related vehicle.

2.5.2.3. There are no service fees to the lessor for the general maintenance of the Zbee, but it is the lessor's responsibility to take the vehicle to the close workshop or another type of facility.

2.6. A Loan vehicle will be provided when the rental vehicle is returned for servicing. The loan vehicle may however not be the same make, model or colour, nor will it have the accessories (if any) of the vehicle on rent.

2.6.1. Scooter will advise if the loan vehicle is available for the Primary Driver/Renter.

2.7. This rental will end in the event of any one or more of the following:

2.7.1. An odometer reading of _____ kilometres is reached;

2.7.2. An accident occurs for which the vehicle is deemed, by Scooter, to be uneconomical to repair, theft of the vehicle;

2.7.3. The customer no longer requires the use of the vehicle (subject to 1 above), or the rental has reached 11 months in duration.

2.8. The cost of required accessories or special equipment to be fitted to the vehicle will be for the account of the Renter and must be paid in full and in advance. These additional costs are not refundable and the renter agrees that the equipment may only be removed from the vehicle if no modification to the vehicle was required in order to fit the accessory and/or will not negatively influence the re-sale value of the vehicle.

2.9. The renter indemnifies Scooter against any claims that result from the use of and/or are associated with the fitted accessories.

3. RISK, DELIVERY AND RETURN

3.1. The VEHICLE will be at YOUR sole risk from the date and time of delivery of the VEHICLE until the VEHICLE is returned to US. YOU undertake to return the VEHICLE in the same condition that YOU received it, fair wear and tear excepted;

3.2. YOU will return the VEHICLE, on the expiry or termination of this AGREEMENT, at YOUR expense to our authorised representative at the collection address recorded in the AGREEMENT. YOU acknowledge that failure to return the VEHICLE in terms of this AGREEMENT will constitute a breach of the AGREEMENT and illegal possession by YOU, and WE may report the VEHICLE as stolen and/or repossess the VEHICLE wherever same may be found and from whomsoever is in possession thereof;

3.3. When YOU or any person nominated by YOU return the VEHICLE to any branch of Scooter, YOU will:

Initial:

- 3.3.1.Park the VEHICLE in Scooter's reserved parking/office;
- 3.3.2.Ensure that the VEHICLE is properly locked and secure;
- 3.3.3.Hand the keys of the VEHICLE to an authorised representative of Scooter when Scooter's offices are open for business;
- 3.3.4.Leave the keys in a drop safe provided at the offices of Scooter when Scooter's offices are not open for business.
- 3.3.5.The sole risk of loss or damage to the VEHICLE will remain vested in YOU until WE have recorded the return of the VEHICLE.
- 3.4.In the case that the delivery of the Zbee is in an area where Scooter does not have an office, it will be the duty of Scooter and the Lessor to arrange pre-expiry of the mini-lease for collection. The collection fee will be the sole responsibility of the Lessor and the logistics of the collection will be the sole responsibility of Scooter.
 - 3.4.1.The collection fee will be determined by Scooter and as such will be charged to the Lessor. This fee will have to be paid in full pre-collection, inclusive of the final payment due to Scooter for leasing the Zbee RS/ Zbee CG.
 - 3.4.2.Scooter will provide this in the form of an invoice (or final invoice) for the Lessor.

4. WARRANTIES BY YOU

YOU warrant that:

- 4.1.All information given by YOU to US is true and correct;
- 4.2.The DRIVER holds a valid unendorsed DRIVER's license for the VEHICLE;
- 4.3.YOU will not drive the VEHICLE under the influence of alcohol or any other central nervous system stimulant;
- 4.4.The DRIVER is not physically prevented from operating the VEHICLE safely;
- 4.5.No person other than the DRIVER will drive the VEHICLE;
- 4.6.The DRIVER will lock the VEHICLE and activate any burglar alarm or protection system installed in the VEHICLE when the same is not in use and ensures that the keys of the VEHICLE are properly controlled;
- 4.7.The VEHICLE will not be used or driven for the conveyance of persons or property for reward, in contravention of or breach of any law, in any race, speed test or contest, on roads not properly constructed, or for towing unless supplied with a tow bar;
 - 4.7.1.An exception can be made if there is an agreement that the vehicle will be used for pilot testing of transportation concepts;
 - 4.7.2.It will be the responsibility of the Lessor to ensure that their insurance covers Passenger Liability.
- 4.8.The VEHICLE will not be used or driven in any way which would constitute a breach of any of the provisions of this AGREEMENT;
- 4.9.YOU and the DRIVER will at all times display an absolute duty of care towards Scooter in respect of the VEHICLE, and YOU will ensure that the VEHICLE will only be used on suitable roads and conditions under the type of VEHICLE hereby rented;
- 4.10.YOU and the DRIVER will not take the VEHICLE into any area or on any road where there is a risk that the VEHICLE may be damaged, stolen or lost through civil disturbance, riot or any act of political unrest;

4.11. The VEHICLE will not be taken outside the Republic of South Africa, except with OUR prior written permission. The cross border letter provided by US will provide YOU with authorisation to cross the relevant border and WE will not be held responsible for any fee/ or other costs/ payments howsoever incurred by YOU crossing the border.

5. PAYMENTS

5.1. YOU agree to pay US:

5.1.1. The VEHICLE rental rates cross border fees per border and other charges as set out in the AGREEMENT and/ or in terms of our OFFICIAL RATES, whichever may be applicable;

5.1.2. THERE IS NO RECHARGING FEE FOR THE ZBEE AS IT IS ELECTRIC;

5.1.3. all fines, taxes, charges, levies, legal costs and tolls, including e-tolls, payable by US to any third party arising out of YOUR use of the VEHICLE;

5.1.4. all and any costs, including but not limited to, one-way fees, towing charges and losses or damages incurred by US in procuring the return of the VEHICLE to the collection address described above, or such other location as determined by US;

5.1.4.1. Delivery address _____.

5.1.4.2. Collection address _____.

5.1.5. If the VEHICLE is not returned on the return date, all amounts that would have been payable by YOU in terms of this AGREEMENT if the RENTAL PERIOD had been validly extended to the actual date of return of the VEHICLE to US;

5.1.6. all costs for which YOU are liable, incurred by US in repairing any damage of any nature whatsoever to the VEHICLE and any loss or damages suffered by US as a result of theft, fire or any other cause whatsoever;

5.1.7. Such valet charge as may be levied for the cleaning of the VEHICLE; and

5.1.8. Such accident administration and/ or traffic fine handling fees may be levied by US.

5.1.9. If WE have agreed to payment from YOU by credit or charge card, YOUR signature will constitute authority for the issuer of the card to debit YOU with the total amount owing, inclusive of all costs and charges of whatsoever nature, arising in terms of this AGREEMENT.

5.1.10. YOU will pay all amounts payable by YOU under this AGREEMENT to US, on-demand. If any payment is not made on its due date, then WE may, without prejudice to any of OUR rights, charge interest on the amount due at the maximum rate permissible by law.

5.2. DEPOSIT-

5.2.1. Refer to 2.1.1

5.2.2. Before the rental location will let you rent the vehicle, they will take a pre-authorisation. You must use an approved payment card that is in your name and has enough funds available on it.

5.2.3. The amount is either fixed – or calculated based on (a) the estimated vehicle rental price, (b) plus the estimated price of all optional extras you've requested, (c) plus an amount to allow for any fuel you may use, (d) plus a weekend deposit (if applicable), (e) less any amount the rental locations accepts you have paid towards the rental when you booked. If you would like more details, please call Reservations.

- 5.2.4. At vehicle return, the final payment amount will be calculated and processed using the payment card provided. If the final payment is greater than the pre-authorisation, the rental location will ask you to pay the difference. If the final payment is less than the pre-authorisation, or you choose to pay using a different method, you will need to contact Customer Services to have the pre-authorisation released.
- 5.2.5. If you choose to pay by a different method, please be aware that the pre-authorisation on the original card will remain until released by your card company.
- 5.2.6. Your card company, not the rental location, is responsible for releasing the pre-authorisation and processing approved refunds, and this can take up to 14 days.

6. Advertising Arrangement

6.1. Scooter will request to advertise third-party brands on your leased Zbee:

6.1.1. The terms of the advertising would be that Scooter emails the lessor requesting to advertise a third-party brand;

6.1.1.1. The benefit of advertising a third-party brand on the Zbee would be that the lessor will receive-

6.1.1.2. R200 per month for the duration of the agreed period by the advertiser in the form of cash payments; or

6.1.1.3. R200 per month would be credited to the lessor, decreasing the monthly rate liable by the lessor.

6.2. If the Lessor would like to brand the Zbee to promote their business, they would be required to pay one of the following:

6.2.1. Full Branding-

6.2.1.1. Set Up Costs options:

6.2.1.1.1. Full Digital Wrap Promotional Vinyl **R9 672**;

6.2.1.1.2. Full Digital Wrap with UV Lamination Cast **R13 095**;

6.2.1.1.3. For Half-Digital or a smaller set of decals, the Lessor would be required to provide their artwork and provide a brief with the dimensions for a quotation to be provided.

6.2.1.1.4. It must be noted that this is a cost per Zbee and works on a discount scale depending on the fleet size that will be branded.

6.2.1.1.5. Should the lessor wish to apply their own branding, with their own supplier, they should provide details of the company.

6.2.1.2. Monthly advertising rates are as follows:

6.2.1.2.1. Advertising Rates are R2 000 payable monthly.

6.3. The Lessor will have to confirm that they intend on branding ___ **(number)** Zbee/s and will be doing so for a period of ___ **(number)** months.

6.4. Scooter is strict on a non-negotiation for branding of its Zbees and must be respected by the Lessor at all times.

6.5. The Lessor is also going to be responsible for maintaining communication with Scooter at all times should there be any damages incurred on the Zbee and the branding to protect the brand of the Lessor that is an advertising and/or the brand of the Third-Party Advertising Client.

7. LIABILITY WAIVERS

7.1. YOU may purchase an insurance coverage fee that may be included in the OFFICIAL RATES, which will cover Collision Damages and Theft Loss at an additional **R399** per month.

Initial:

- 7.2. In such event, YOUR liability in terms of clause 2.1 will not exceed the amount stated in the AGREEMENT as of the "Renter's Responsibility", unless one or more of the exclusions in clause 5.3 is applicable.
- 7.3. The LIABILITY WAIVERS do not cover loss of or damage to the VEHICLE in the following circumstances, and YOU will be liable for all such loss or damage:
- 7.3.1. Where YOU or the DRIVER are in breach of this AGREEMENT;
- 7.3.2. Where damage is caused to all glass, mirrors, lamps, tyres, rims, hubcaps, hub motors, windscreens or the undercarriage, if no collision of the VEHICLE has occurred;
- 7.3.3. Where damage is caused by water;
- 7.3.4. Where damage or loss is caused by DRIVER negligence;
- 7.3.5. Where damage or loss is sustained in an accident not caused by physical contact with another vehicle, person, animal or object;
- 7.3.6. Where damage is caused by YOUR failure to ensure that the VEHICLE's required lubricant levels are maintained;
- 7.3.7. Where damage or loss is caused by potholes, sand or travelling on gravel roads; and
- 7.3.8. In respect of personal belongings, key replacement, towing fees and claim administration fees.
- 7.4. YOU may not decline the LIABILITY WAIVERS offered by US unless:
- 7.4.1. There is a valid corporate account opened in YOUR name; and
- 7.4.1.1. Currently not applicable.
- 7.4.2. YOU have signed OUR "Self Insurance Agreement"; and
- 7.4.2.1. Currently not applicable.
- 7.4.3. YOU have provided US with written proof from YOUR insurers that all vehicles rented are **comprehensively** insured.
- 7.5. Subject to our consent, you may, in addition to the LIABILITY WAIVERS, purchase in advance a windscreen and/or tyre waiver. These additional waivers only cover damages to viewing glass caused by stone chips, and tyres, rims and hubcaps caused by potholes and do not cover theft of the said items.

8. EXTENSION OF RENTAL PERIOD

- 8.1. YOU will be entitled at any time during the initial period to orally extend the RENTAL PERIOD.
- 8.2. This extension will however only be valid if confirmed by US in writing.

9. TERMINATION

- 9.1. WE will be entitled to terminate this AGREEMENT if YOU and/or the DRIVER commit any breach of this AGREEMENT. WE will then be entitled to the immediate return of the VEHI-

CLE, and any amount then and there owing by YOU to US will become immediately due and payable.

9.2.Both YOUR and OUR rights and obligations under this AGREEMENT will continue to be in full force and effect until the VEHICLE has been returned to US in terms of this AGREEMENT and YOU have complied with all YOUR obligations in terms hereof.

10. INDEMNITY

10.1.Save as provided for in law and provided that there was no negligence on our part, we will not be held liable for any damages, injury, death, consequential loss, loss of profits, or any other damages which the renter or the driver or any person transported in the vehicle may suffer arising out of this agreement.

10.2.Subject to clause 2.5 of this Agreement, the renter and driver will not be held liable for any damage and/or injury and/or death, for any loss or damages to any property transported in or left in the vehicle arising out of any defect in and/or mechanical failure of the vehicle.

11. RESPONSIBILITY AFTER LOSS OR DAMAGE TO VEHICLE

11.1.If the VEHICLE is involved in an accident or collision, or is lost or stolen, or is involved in an incident, which could prejudice OUR rights, the RENTER and/or DRIVER will take all such steps to safeguard OUR interests, including, but not limited to the following where appropriate:

11.1.1.Obtain the names and addresses of everyone involved and of possible witnesses, and details of other vehicles involved;

11.1.2.Not, without our prior written consent, admit any responsibility or liability or release any party from any liability or potential liability, nor settle any claim or potential claim against or by any party, nor accept any disclaimer of liability;

11.1.3.Notify the police and US as soon as possible and in any event within 24 hours of the incident;

11.1.3.1.Notify Scooter on admin@greenscooterza.com / sales@greenscooterza.com / accounts@greenscooterza.com.

11.1.4.Within 48 hours of the incident complete and furnish to US OUR fully completed standard claim form;

11.1.5.Within 48 hours of the incident submit to US a copy of the DRIVER's licence;

11.1.6.Not abandon the VEHICLE and make adequate provision for its safety and security; and

11.1.7.Cooperate with US in any investigation, the lodging or instituting of any claim or action and the defence of any prosecution, claim or action relating to the above;

12. GENERAL

- 12.1. YOU acknowledge that ownership in the VEHICLE will at all times remain vested in US, or the true owner of the VEHICLE.
- 12.2. YOU will not be entitled to cede or assign any of YOUR rights and obligations under this AGREEMENT or to sublet or part with possession of the VEHICLE.
- 12.3. You are not permitted to carry out any repairs, including replacing any tyres, on the VEHICLE.
- 12.4. Any tampering by YOU with the odometer of the VEHICLE will be regarded as fraud. Where required in determining the rental charges, the distance driven by YOU or the DRIVER will be measured from the odometer installed in the VEHICLE. If such calculation is not practical or possible for any reason whatsoever, the calculation will be done by such other reasonable method as WE may determine and YOU will be obliged to furnish all such information and assistance as WE may reasonably require for that purpose.
- 12.5. If the RENTER is not the DRIVER, then, without in any way detracting from the RENTER's obligations in terms of this AGREEMENT, the RENTER and the DRIVER will be liable to US jointly and severally for all and/or any amounts owing under this AGREEMENT.
- 12.6. Please be advised that although WE will use our best efforts, WE are unable to guarantee the availability of the VEHICLE to YOU at a particular time due to possible circumstances beyond our control. If WE are however unable to do this, WE will endeavour to make alternative arrangements until WE can make the VEHICLE available to YOU.
- 12.7. Save as otherwise stated in this AGREEMENT any addition to or alteration of this AGREEMENT will be null and void unless agreed upon by US in writing.
- 12.8. YOU agree that WE may sue YOU in the Magistrate's Court for all purposes under this AGREEMENT, notwithstanding that the subject matter, cause of action, or amount involved be otherwise beyond the jurisdiction of the said court.
- 12.9. YOU choose the address where YOU will receive notices for all purposes in terms of this AGREEMENT, at the RENTER's address specified in the AGREEMENT or, in the case of that address not being in the Republic of South Africa, at the DRIVER's local address specified in the AGREEMENT.
- 12.10. A certificate of any director, manager or accountant of Scooter as to the amount owed by YOU to US will, on the face of it, constitute proof of the amount owing.
- 12.11. This document contains the entire AGREEMENT between YOU and US regarding the matters contained herein and WE will not be bound by any undertakings, representations, warranties, promises or the like not recorded herein unless otherwise stipulated by law.
- 12.12. It is agreed that each clause of these terms and conditions is severable, the one from the other, and if any clause is found to be defective or unenforceable for any reason by any

competent Court, then the remaining clauses will be and continue to be of full force and effect.

12.13.This AGREEMENT will be governed by and interpreted under the laws of the Republic of South Africa.

12.14.No extension, relaxation or other leniencies that may be given or allowed by US can be taken to mean that other rights may not be enforced.

12.15.The RENTER and/or DRIVER authorise US to conduct any credit checks which WE deem necessary to adequately assess the risk of contracting with YOU. WE are entitled to note any default by YOU in terms of this AGREEMENT and, in accordance with The National Credit Act's requirements, with any credit bureau, and YOU hold US blameless for any consequences arising from the notation.

YOU have read and understood the terms and conditions of this AGREEMENT. YOUR attention has been drawn to the following important clauses:

Clause 2.1: The VEHICLE is rented at YOUR sole risk

Clause 4.1: YOU agree to pay US all amounts owing in terms of this AGREEMENT

Clause 5: YOU may purchase in advance LIABILITY WAIVER to potentially reduce YOUR liability

Clause 8: YOU indemnify US from liability in certain circumstances
